

### **COVERAGE:**

- **1.1** This Guarantee covers the doors supplied by ABS Doors & Timber, and it applies to defects in material and workmanship found in the doors during normal use and service.
- **1.2** The Guarantee is valid for a period of 5 years from the date of purchase.

### **GUARANTEE BENEFITS:**

- **2.1** In the event that a defect covered by this Guarantee is identified within the guarantee period, we will, at our sole discretion:
  - a) Repair the defective door component(s) or
  - **b)** Replace the defective door component(s) with an equivalent or similar product.

### **GUARANTEE EXCLUSIONS:**

- **3.1** This Guarantee does not cover damage or defects resulting from:
  - a) Improper installation, handling, or use of the doors.
  - b) Lack of proper maintenance or failure to follow the care and maintenance instructions provided by ABS Doors & Timber.
  - c) Misuse, abuse, or intentional damage caused by the client or any third party.
  - **d)** Alterations, modifications, or repairs made by unauthorised personnel.
  - e) Acts of nature, fire, flood, earthquake, or other external events beyond the control of ABS Doors & Timber

### **CLIENT'S OBLIGATIONS:**

- **4.1** To avail themselves of the benefits of this Guarantee, the client must:
  - a) Notify ABS Doors & Timber in writing promptly upon discovering the defect covered by this Guarantee.

- **b)** Provide proof of purchase or installation, along with a detailed description and supporting evidence of the claimed defect.
- c) Cooperate with ABS Doors & Timber in the inspection and evaluation of the claimed defect, if required

### LIMITATIONS OF LIABILITY:

- 5.1 To the fullest extent permitted by law, ABS Doors & Timber's liability under this Guarantee is limited to the repair or replacement of defective door components as stated in Section 2.
- 5.2 ABS Doors & Timber shall not be liable for any indirect, incidental, consequential, or special damages arising from the use or inability to use the doors covered by this Guarantee.
- **5.3** This Guarantee does not affect the client's statutory rights under applicable consumer protection laws.

# TRANSFERABILITY:

6.1 This Guarantee is transferable to subsequent owners of the doors during the guarantee period, provided that the new owner notifies ABS Doors & Timber in writing of the transfer.

## **DISPUTE RESOLUTION:**

- **7.1** Any dispute arising out of or in connection with this Guarantee shall be resolved through good faith negotiations between the parties.
- **7.2** If a resolution cannot be reached, the parties agree to submit the dispute to mediation or arbitration.
